## DOMESTIC RULES

1. It is not allowed to participate in class under the influence of alcohol, drugs and/or sleep-inducing medicines.
2. Intolerant, aggressive, racist, discriminatory, dominant or sexist behavior is not tolerated in our school.
3. You are kindly requested to be present and on time for the classes. Care is taken to mean: clean clothes, clipped nails and good body care. If you do not comply with our request, you may be denied participation in a class.
4. For safety reasons, it is not allowed to wear jewelry, piercings, etc. during class. If temporary removal is impossible, the relevant body part should be taped. The wearing of headgear, including headscarves, is not allowed during the lessons for safety reasons. Exceptions are made if there is a medical reason for wearing it.
5. We expect you to behave with dignity at all times, both inside and outside the school. If you abuse the learned techniques, you will be removed from the list by the management of our school and related schools and categorically banned.

## CONTRACTUAL RIGHTS AND OBLIGATIONS

1. You are entitled to two free trial weeks after which you can decide whether you want to continue with your preferred martial art(s).
2. **Your contract is valid for one year.** After that you can cancel the subscription per month (registration costs one time 15 euros)
3. It is not permitted to teach what has been taught to third parties, without the permission of the head teacher.
4. For your safety and those of others, and because of your and our accident insurance, you are obliged to purchase any necessary clothing and protectors that belong to the martial arts classes you have chosen.
5. In the interest of your safety, and that of other class participants, you must abide by the instructions of the professional management and the above regulations at all times. Adverse consequences as a result of not, or not completely, complying with the instructions or the regulations are entirely your own responsibility.
6. Damage or loss of your personal property is not covered by our school's liability or insurance scheme.
7. Expenses for material damage caused by you, accidentally or on purpose, will be recovered from you or your insurance.
8. If you miss a number of lessons unannounced, your payment arrangement will not expire. After all, you can always catch up with these lessons, at a different date and time, free of charge in another group.
9. If you wish to terminate your contribution, you must inform us personally or in writing. If you do not do this, the contribution obligation will automatically continue. If you wish to end the training for a short time due to work, moving or the like, then the options for this should be discussed with the head teacher of the school. In the event of cancellation, the month of cancellation is the last month to be collected by us.
10. Direct debit always takes place around the 20th day of the month. In the event of arrears, we can engage a collection agency.
11. Every 2nd family member receives a 10% discount on the monthly amount when joining classes. We also apply a total family discount of 12%.
12. With direct payment for half a year you will receive a discount of 5% on the total amount.
13. Photos or images taken during lessons or courses may be used for promotion by the management, without further consultation, provided you have clearly indicated in advance that you do not want to participate in this.
14. Members from Wijchen pay for other styles, other than karate, € 10,00 extra per month extra when participating in Oss.

### privacy policy personal data

*In 2018, the General Data Protection Regulation ("Regulation" or "GDPR") is directly applicable in all Member States of the European Union. The Regulation is the successor to the Personal Data Protection Act in the Netherlands. The purpose of the Regulation is to safeguard two interests:*

- 1. the protection of natural persons with regard to the processing of their data and*
- 2. the free movement of personal data within the European Union ("EU").*
